Chapters numbered 1, 2, 3, 4 and 5; holding warrants from the General Grand Chapter, established the Grand Chapter of Colorado May 11, 1875. The dates of the Dispensations and Charters by the General Grand Royal Arch Chapter of the United States are as follows: Central City #1, Dispensation March 23 1863, Charter September 8, 1865; Denver #2, Dispensation April 1863, Charter September 8, 1865; Pueblo #3, Dispensation May 24, 1871, Charter September 20, 1871; Georgetown #4, Dispensation August 12, 1872, Charter November 25, 1874; and Golden #5, Dispensation December 8, 1873, Charter November 25, 1874.

Most Excellent Companion Gordon R. Merrick (11) served the General Grand Chapter as Most Excellent General Grand High Priest, 1975-1978.

Colorado now has **27** Chartered Chapters with a membership of 1,327 as of June 30, 2011.
